Rice Subsidy for Pantawid Pamilya Beneficiaries

Whereas, the Pantawid Pamilyang Pilipino Program (Pantawid Pamilya) National Advisory Committee (NAC) is the highest policy-making interagency body that provides policy directions and guidance on matters pertinent to program implementation;

Whereas, to address hunger and malnutrition, and provide immediate food support to Pantawid Pamilya beneficiaries, President Rodrigo Roa Duterte, in his first State of the Nation Address, directed the DSWD to provide rice subsidies to the poor;

Whereas, for 2017, the Congress has included a budget of Php 23,400,000,000.00 for Pantawid Pamilyang Pilipino Program as part of the overall grants appropriated;

Whereas, this appropriation can be used to implement the rice subsidy to the beneficiaries;

Now, therefore, be it RESOLVED as it is hereby resolved by the members of the NAC, this 24th of November 2016, to adopt the following:

1. *Scope of Rice Subsidy*

All active beneficiaries of Pantawid Pamilyang Pilipino Program, whether under the Regular CCT, Modified CCT, and Transitioning Households, as of 31 December 2016, will receive rice subsidy.

2. *Form of Rice Subsidy*

Rice subsidy will be given in cash in addition to the regular cash grants that they receive.


3. *Amount of Rice Subsidy*

All household beneficiaries are entitled to receive rice subsidy in equal amount per household per month, which shall be provided in addition to their cash grants during payouts.



Depending on the availability of budget and policy changes, the rice subsidy as stated herein is subject to modification by subsequent NAC resolutions, Department orders, Presidential directives, and other related laws.




