NAC Resolution No. 42 Series of 2018

> Amendment to NAC Resolution 1 on the Deworming Age Coverage of Pantawid Children Beneficiaries

WHEREAS, the Pantawid Pamilyang Pilipino Program National Advisory Committee (NAC) is the highest policy-making interagency body that provides policy directions and guidance on matters pertaining to program implementation;

WHEREAS, NAC Resolution 1 Series of 2010 on the Conditionalities/Co-responsibilities (Beneficiaries) states that all beneficiaries once registered and validated shall comply with all conditions or coresponsibilities including the deworming of children 6-14 years old every six months;

WHEREAS, to address the concern of different deworming age coverage of Pantawid and DOH, and to give children better health protection, the members of the NAC-TWG, during the 3<sup>rd</sup> NAC-TWG Meeting last 26 July 2018, recognized the need to revise the age coverage for deworming of Pantawid beneficiaries:

Now therefore, be it RESOLVED as it is hereby resolved by the members of the NAC in a meeting held on 30 August 2018, the following provision in the NAC Resolution 1 is hereby amended.

Under Section 1 Conditionalities/Co-responsibilities (Beneficiaries): 1.4 "Children 6-14 years old shall avail of deworming pills every six months."

The aforementioned is hereby amended to read as follows:

"All-eligible-Pantawid-children-beneficiaries in the household shall avail of the deworming service according to existing DOH guidelines and protocols."

All existing Pantawid policies inconsistent with the provisions of this resolution are hereby repealed or amended accordingly.
