NAC Resolution No. 3 Series of 2022

INCLUSION OF SAVE THE CHILDREN PHILIPPINES, INC. (SCP) AS A PANTAWID PAMILYANG PILIPINO PROGRAM-NATIONAL ADVISORY COUNCIL MEMBER FOR THREE YEARS (2023-2026)

WHEREAS, Republic Act No. 11310, otherwise known as the "Pantawid Pamilyang Pilipino Program (4Ps) Act", defines 4Ps as the national poverty reduction strategy and a human capital investment program that provides conditional cash transfer to poor households for a maximum of seven (7) years, to improve the health, education, and nutrition aspect of their lives

WHEREAS, Section 15 of the 4Ps Act, and as reiterated in its Implementing Rules and Regulation (IRR), provides the composition of the National Advisory Council (NAC) and Regional Advisory Council (RAC), to wit:

"Advisory Council. An Advisory Council shall be created at the regional and national levels to be headed by the DSWD.

The regional advisory councils and NAC shall have, as members, representatives from the DSWD, Department of Health (DOH), Department of Education (DepEd), Department of Agriculture (DA), Department of Labor and Employment (DOLE), Department of Trade and Industry (DTI), Department of Agrarian Reform (DAR), Department of Science and Technology (DOST), and Technical Education and Skills Development Authority (TESDA). The regional advisory councils and NAC shall also have, as additional members, two (2) representatives from accredited nongovernmental organizations working or monitoring social welfare service programs."

WHEREAS, Section 39, Rule XVII of the 4Ps Act IRR states that the NAC shall be the policy-making body manifested through the approval of resolutions and enhancement of guidelines aimed towards ensuring supply side requirements and necessary support for household members to meet the conditions for entitlement and strengthening of the overall implementation of the Program. It shall formulate and recommend to the President policies and strategies to enhance and improve program implementation which is aimed towards enhancement of national and local efforts with partner agencies in ensuring that the necessary support for qualified household-beneficiaries are provided towards improvement of their well-being.

WHEREAS, Section 15 of 4Ps Act and Section 41 of its IRR provide that the NAC shall also have, as additional members, two (2) representatives from accredited non-governmental organizations working or monitoring social welfare service programs, subject to the DSWD accreditation.

WHEREAS, Section 41 of the IRR of the 4Ps Act provides that the membership of the NGOs to the NAC/RAC shall be valid for three (3) years.

WHEREAS, NAC Resolution No. 3, Series of 2021 entitled, "A Resolution on the Selection of Two (2) Non-Government Organizations (NGOs) as members of the National and Regional Advisory Council" provides for the selection process and criteria for identifying the NGOs to be part of the Advisory Councils.

WHEREAS, the representatives of the NGO, as additional members of the NAC/RAC, shall also have the same status and voting powers as the other members of the Advisory Councils.

WHEREAS, Save the Children Philippines, Inc. (SCP), is committed to ensure that the most impacted by inequality and discriminated children learn, survive and are protected in both development and humanitarian context through strengthening the resilience and participation of parents, caregivers and children through child rights-based programming in achieving their developmental milestone as they go through child various life stages: early years (0-5 years old), middle childhood (6-12 years old) and adolescence (13 to below 18 years old).

WHEREAS, SCP has satisfied the requirements indicated in the NAC Resolution No. 3 s. 2021 and the corresponding Guidelines in the selection of the two (2) NGOs as members of the NAC/RAC of the 4Ps.

WHEREAS, the Terms of Reference for the two (2) NGOs as member of the NAC has adopted by the Council which therefore guided by the Secretariat in the Selection Process.

NOW, THEREFORE, pursuant to the powers vested to the NAC, it is RESOLVED as it is hereby resolved by the members of the NAC, in a meeting assembled on 15 December 2022, to approve the said resolution that SAVE THE CHILDREN PHILLIPINES, INC. as the Regular Membership of the NAC is hereby adopted;

RESOLVED, SCP shall be included as a regular member of the NAC for a maximum period of three (3) years from 2023 to 2026, unless otherwise revoked by both parties;

RESOLVED, as it is hereby resolved, that this resolution facilitates the engagement terms of SCP in the NAC.
